Limit of 50 combined WC/WCX entries and 30 Pee Wee entries. All dogs will run under the GRCA WC/WCX rules and will be assigned a running number by random order of the draw. Running order will be drawn at closing at the house of the secretary and will be posted at www.pvgrc.org within 48 hours.

Preference will be given to Golden Retrievers currently untitled in the stake entered. If the limit is not reached, the remaining entry will be filled with untitled dogs of other breeds, then titled Golden Retrievers, then titled dogs of other breeds.

Birds: Pheasants on land, ducks on water for WC/WCX.

Puppies will retrieve the handler's choice (pigeons or bumpers).

Prizes: A rosette and PVGRC duck band will be awarded to qualifiers in the WC and WCX stakes. Placement rosettes will be awarded in the Pee Wee Hunter Stakes.

WCX Test: Entry fee \$40, Start time 9am.

WC Test: Entry fee \$35, Start time to follow WCX land.

Pee Wee Hunter Stakes: Entry fee \$10, Start time 11am.

Note: Dogs entered in either the WC or WCX are NOT eligible to enter the Pee Wee Hunter Stakes.

- Wingers may be used in the WCX test at the judges' discretion.
- Bitches in season are NOT allowed on the test grounds.
- Refunds will be made for bitches in season or injured dogs, if a veterinarian's certificate is provided to the Test Secretary no later than 10 days following the event.
- No food is available on the grounds. However, food is available within 10 minutes drive of the site. Alcoholic beverages are not permitted on the site.
- Non-Golden owners are responsible for handling the necessary paperwork for certificates and approval from the specific parent breed club.

Directions:

Take MD route 301 to Cherry Tree Crossing Road, which is located across Route 301 from the Veterans' Cemetery (approximately 5 miles North of Waldorf). Turn onto Cherry Tree Crossing Road (left if traveling South, right if traveling North). Cross the railroad tracks and turn right on Cherry Tree Crossing Road. Turn left into the driveway at 12100 Cherry Tree Crossing Road. (If you cross a second set of railroad tracks, you have gone too far.)

Once on the property: Please observe the posted speed limit of 5mph, drive and park ONLY on the roads or where directed, and do not scoop your dog's waste.
