GENERAL INFORMATION

Entry fees. TD - \$65.00; TDX - \$100.00. Includes \$0.50 AKC Recording Fee and \$1.50 AKC event service fee.

Mail all entries with fees to Donna Thompson, 1144 Reynolds Rd., Cross Junction, VA 22625. Make checks payable to PVGRC. There will be a \$25 collection fee added for any returned check.

DRAWING OF ENTRIES: Entries shall be accepted until the official closing date, even though the advertised limit has been reached. Entries will be drawn by the Test Secretary on Thursday, October 29, 2015, at 6 p.m. at the home of the secretary. The Drawing shall be completely random among all entries received, except that preference shall be given to dogs in the following order: Draw (1) Specialty breed without a title; Draw (2) Specialty breed with a title; Draw (3) Other breeds without a title; Draw (4) Other breeds with a title. When the advertised limit has been drawn, remaining entries, subject to the same preferences set forth above, shall be assigned a position on an Alternate List corresponding to the order in which they were drawn. The Test Secretary shall then notify all entries of the results of the draw.

Certification. With each TD test entry of a dog that has not passed an AKC tracking test, there must be filed an original statement, dated within one year, signed by a person who has been approved by the AKC to judge a tracking test, certifying that the dog is considered to be ready for such a test.

Bitches in season may participate. They will be assigned the last track(s). Please report to the Test Secretary before the drawing for track order on the morning of the test.

Refund policy. No entry shall be refunded except as follows. Entry fees and certification will be returned within 7 days following the test for an alternate who does not participate in the test. Entry fees shall be returned for a dog withdrawn because it has passed a tracking test between close of entries and Saturday, November 7, 2015, if such dog is replaced by an alternate. Withdrawal requests must be made to the Test Secretary by Saturday, November 7, 2015.

Drawing for the running order of TD tracks will take place at Test Headquarters on the date of the test at 7:30 a.m. Drawing for the running order of TDX tracks will take place at 9:30 a.m.

Directions to Test Headquarters. From Winchester, VA, go north on Rt. 522 exactly 15 miles to a right on Reynolds Rd. (This road is directly across from Liberty Truck Stop.) Go 2 miles to the little red schoolhouse that is on your right. The actual address is 1144 Reynolds Rd., Cross Junction, VA.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.

I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
