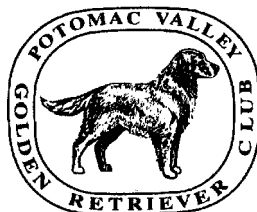

GENERAL INFORMATION

Entry fees. TD \$75.00, TDX \$125.00. Includes \$0.50 AKC Recording Fee and \$3.00 AKC event service fee.

Mail all entries with fees to Bob Kurtz, Test Secretary, at 3899 Hickory Cove Ln, Moneta VA 24121. Make checks payable to "PVGRC". There will be a \$25 collection fee added for any returned check. **Please check any relevant state and/or local travel and quarantine restrictions before entering.**

DRAWING OF ENTRIES: Entries shall be accepted until the official closing date, even though the advertised limit has been reached. Please do not send an entry that requires a signature for acceptance. Entries will be drawn by the Test Secretary on Thursday, October 29, 2020, at 6 pm, at the home of the secretary. The Drawing shall be completely random among all entries received, except that preference shall be given to dogs in the following order: Draw (1) Specialty breed without a title; Draw (2) Specialty breed with a title; Draw (3) Other breeds without a title; Draw (4) Other breeds with a title. When the advertised limit has been drawn, remaining entries, subject to the same preferences set forth above, shall be assigned a position on an Alternate List corresponding to the order in which they were drawn. The Test Secretary shall then notify all entries of the results of the draw. There will be an alternate TDX track. There will not be an alternate TD track. In accordance with Section 12 of the AKC Tracking Regulations, the Test Secretary may enter.

Certification. With each TD test entry of a dog that has not passed an AKC tracking test, there must be filed an original statement, dated within two years, signed by either an approved tracking judge or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, certifying that the dog is considered to be ready for such a test. **Note that the AKC has extended certifications expiring March 1, 2020 through December 31, 2020 for an additional one year period after expiration; such expired certifications will be accepted.**

Bitches in season may participate. They will be assigned the last track(s). Please report to the Test Secretary before the drawing for track order on the morning of the test.

Refund policy. No entry shall be refunded except as follows. Entry fees and certification will be returned within 7 days following the test for an alternate who does not participate in the test. Entry fees shall be returned for a dog withdrawn because it has passed a tracking test between close of entries and Saturday, November 7, 2020, if such dog is replaced by an alternate. **Entry fees shall be returned for an exhibitor with a positive COVID test, COVID symptoms, known COVID exposure, or subject to post-closing-date changes in government-imposed travel restrictions.** Withdrawal requests must be made to the Test Secretary by Saturday, November 7, 2020.

Drawing for the running order of TD tracks will take place at Test Headquarters on the date of the test at 7:30 a.m. Drawing for the running order of TDX tracks will take place at 9:30 a.m.

Trophies: PVGRC will present a rosette to each dog rated "passed" in the test.

Cancellation due to Extraordinary Conditions: The club reserves the right to cancel the test in the case of extraordinary conditions. Such conditions may include, but not be limited to, extreme weather, event restrictions placed on outdoor events by Federal, State, or local authorities due to COVID-19, or an increase in COVID-19 activity for which the club deems cancellation of the event to be appropriate. In such an event, all entries and alternates will be notified as quickly as practical by email, phone, and/or text message and fees will be returned.

Directions to Test Headquarters:

---From Frederick and points north and suburban MD: Take I-70 or I-270 to Frederick, then exit on Rt. 15 south / Rt. 340 west. In about 5 miles, exit left on Rt. 15 south towards Leesburg. Immediately after crossing the bridge over the Potomac into Virginia, turn right on Lovettsville Rd. In 5 miles, Moon Lake Lane is on the right (you will see a large brick house and then the lake). Follow the signs to test headquarters.

---From Leesburg and points south and suburban northern VA: Take Rt. 7 west or Rt. 267 west (Dulles Greenway toll road) to Leesburg, then take Rt. 15 north. Pass through Lucketts and continue until road gets windy. Shortly after passing under the yellow blinking sign and immediately before crossing the bridge over the Potomac into Maryland, turn left on Lovettsville Rd. In 5 miles, Moon Lake Lane is on the right (you will see a large brick house and then the lake). Follow the signs to test headquarters.

---From Winchester and points west: Take Rt. 7 east, exit at Rt. 287 Berlin Tpk in Purcellville and turn left. Continue on Rt. 287 into Lovettsville, at the town square turn right (in front of the 7-11) on E. Broad Way. Pass the community center on the left, then turn left on Lovettsville Rd. In 1 mile, Moon Lake Lane is on the left. Follow the signs to test headquarters.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
